APPLICATION DUE TO LIMITED AVAILABILITY ALL VENDORS MUST EMAIL A PHOTO REPRESENTING HOW YOUR SPACE WILL APPEAR AT OUR FESTIVAL AND A BRIEF DESCRIPTION TO DAVISM@CANADIANCOUNTY.ORG. ONCE APPROVED YOU WILL RECEIVE A LINK & CODE TO ACCESS OUR ONLINE REGISTRATION & APPLICATION.

LOAD IN

FRIDAY OCTOBER 14TH, 2022

11AM-4PM: VENDOR LOAD IN OPTION #1

SATURDAY OCTOBER 15TH, 2022

6AM-9:30AM: VENDOR LOAD IN OPTION #2 (WE SUGGEST YOU LOAD IN ON OCTOBER 14TH)

NO TOLERANCE, YOU MUST BE DONE LOADING IN BY NO LATER THAN 9:30AM WITH YOUR NON-ESSENTIAL VEHICLES REMOVED. PLAN AHEAD AND ALLOW EXTRA TIME SO YOU DON'T GET CAUGHT WITH NO LOAD IN TIME LEFT.

SAMPLES & FESTIVAL BUCKS

BY PURCHASING YOUR SPACE, YOU AGREE TO PROVIDE TOOTHPICK/BITE SIZE SAMPLES TO ALL TICKET GOERS WITH THE CORRECT ARM BRACELET. THIS IS ONE OF THE REASONS THEY'RE COMING, SO MAKE SURE TO PLAN ACCORDINGLY. THE EXPO & EVENT CENTER WILL PROVIDE THE TOOTHPICKS. YOU ALSO AGREE TO ACCEPT \$15 IN FESTIVAL BUCKS THAT WILL BE GIVEN AWAY FOR PROMOTION & DOOR PRIZES.

CHECK IN/REGISTRATION

ALL ENTRIES ARE MADE ONLINE ONLY. YOU WILL BE ASSIGNED YOUR SPACE AND SENT A LAYOUT TO THE EMAIL ADDRESS YOU PROVIDED WHEN PURCHASING YOUR ENTRY. THIS LAYOUT WILL BE SENT PRIOR TO LOAD IN. YOU WILL USE THIS AS YOUR GUIDE. ALL SPACES WILL BE MARKED IN ADVANCE. THE FESTIVAL WILL HAVE AN INFORMATION BOOTH SHOULD YOU NEED ASSISTANCE WITH A BOOTH MANAGER AVAILABLE TO HELP ANSWER QUESTIONS AND HANDLE ISSUES THAT MAY ARISE ONSITE.

REFUNDS: THERE ARE NO REFUNDS, NO NEED TO ASK.

- FOOD TRUCKS OFFER FAST FESTIVAL FOOD THAT IS PREPARED WITHIN THEIR TRUCK. ALL OPERATIONS STAY WITHIN THE TRUCK.
- FOOD VENDORS PREPARE AND SELL FOOD FROM A 10X10 POP UP TENT. OPERATIONS CANNOT EXTEND OFF THE SIDES OF THE BOOTH.

BEVERAGE RULES: ALL FOOD TRUCKS AND FOOD VENDORS MAY SELL ANY NON-ALCOHOLIC BEVERAGES.

ELECTRICITY: MUST PROVIDE YOUR OWN GENERATOR UNLESS YOU RENT AN RV SLIP (50AMP & 30AMP & WATER) FOR AN ADDITIONAL \$45 PER NIGHT. RV SLIPS MUST BE REQUESTED AT THE TIME OF APPLICATION AND ARE ONLY AVAILABLE WHILE SUPPLIES LAST.

FIRE EXTINGUISHERS: ALL FOOD TRUCKS AND FOOD VENDORS DEEP FRYING MUST HAVE CURRENT K-TYPE FIRE EXTINGUISHERS WITH CURRENT SERVICE TAGS. FOOD TRUCKS AND FOOD VENDORS THAT ARE NOT FRYING, MUST HAVE A MINIMUM OF ONE, 2A:20BC AND ONE K RATED FIRE EXTINGUISHER.

HEALTH PERMIT: ALL FOOD VENDORS ARE RESPONSIBLE FOR ANY HEALTH DEPARTMENT PERMITS OR LICENSE THEY MAY NEED. IT IS THE RESPONSIBILITY OF THE VENDOR TO CONTACT THE HEALTH DEPARTMENT SEPARATE FROM THE EXPO & EVENT CENTER. THE CANADIAN COUNTY EXPO & EVENT CENTER IS NOT INVOLVED WITH THIS PERMIT BEING ISSUED.

POLICIES & PROCEDURES

FOR FOOD VENDORS (NOT COMPETING JUST SELLING STUFF)

SAFETY & SECURITY:

- APPLICANTS SHALL SELL AND SERVE FOOD AT THEIR OWN RISK.
- APPLICANTS MUST OBEY ALL PERTINENT SAFETY CODES AND LAWS, INCLUDING, BUT NOT LIMITED TO, FIRE, SAFETY AND PARKING REGULATIONS.
- EVENT RESERVES THE RIGHT TO SHUT DOWN ANY VENDORS NOT MEETING CLEANLINESS AND FOOD STORAGE SAFETY CODES AND LAWS.
- CANOPY TENTS MUST BE FIRE RETARDANT; OPEN FLAMES MUST BE LOCATED A MINIMUM OF 10' AWAY FROM ALL CANOPY MATERIALS.
- ALL CANOPIES, TENTS AND OTHER TEMPORARY STRUCTURES MUST BE WEIGHTED BEFORE YOU ARE PERMITTED TO OPEN, WITH THE EQUIVALENT OF 40 POUNDS PER POLE MINIMUM. BOOTHS MAY NOT OPEN UNTIL PROPERLY WEIGHTED. FESTIVAL MAY SHUT YOU DOWN FOR NOT HAVING PROPER WEIGHTS.

SPACE:

- FOOD TRUCKS AND FOOD VENDORS WILL ABIDE BY EVENT STAFF REQUIREMENTS REGARDING LOCATION(S).
- EVENT RESERVES THE RIGHT TO CHANGE A VENDOR LOCATION AT ANY TIME.
- FOOD TRUCKS AND FOOD VENDORS WILL PROVIDE ALL REQUIRED EQUIPMENT FOR OPERATIONS AND SALES.
- FOOD TRUCKS AND FOOD VENDORS A FRAME SIGNS CANNOT EXTEND FURTHER THAN 3 FEET FROM FAÇADE OF BOOTH. FOOD TRUCKS AND FOOD VENDORS ARE LIABLE FOR ANY INJURY OR DAMAGE CAUSED BY SIGNS.
- ANY FOOD VENDORS THAT FRY MUST BE IN A FOOD TRUCK ONLY. FOOD VENDORS WITH A POP-UP TENT ARE NOT PERMITTED TO FRY.

WASTE:

- NO GREASE OR GRAY WATER DISPOSAL IS AVAILABLE.
- NO WATER PROVIDED BY EVENT UNLESS YOU RENT AN RV SLIP (50AMP & WATER) FOR AN ADDITIONAL \$45 PER NIGHT. RV SLIPS MUST BE RESERVED AT THE TIME APPLICATION AND ARE ONLY AVAILABLE WHILE SUPPLIES LAST.
- FOOD SNACK & FOOD TRUCKS VENDORS ARE RESPONSIBLE FOR REMOVING DEBRIS AND ENSURING THE GENERAL CLEANLINESS OF THE AREA WEATHER:
- THE FOOD TRUCK FESTIVAL WILL TAKE PLACE RAIN OR SHINE. APPLICANTS AGREE TO BE PRESENT DESPITE WEATHER CONDITIONS. EACH PARTICIPANT IS RESPONSIBLE FOR PREPARE THEIR DISPLAYS TO WITHSTAND WEATHER FLUCTUATIONS INCLUDING RAIN AND WIND.

LEGAL FOOD TRUCKS AND FOOD VENDORS ARE INDEPENDENT CONTRACTORS:

FOOD TRUCKS AND FOOD VENDORS EXECUTE THIS AGREEMENT AS INDEPENDENT CONTRACTORS AND SHALL AT ALL TIMES HAVE COMPLETE SUPERVISION, DIRECTION, AND CONTROL OVER THE SERVICES TO FULFILL REQUIREMENTS. VENDORS EXECUTE THIS AGREEMENT AS INDEPENDENT CONTRACTORS, NOT AS AN EMPLOYEE OF EVENT. VENDORS WILL ASSUME RESPONSIBILITY FOR APPROPRIATE PAYMENT OF PAYROLL TAXES AND CHARGES UNDER APPLICABLE FEDERAL AND LOCAL LAW. VENDORS AGREE TO TAKE COMPLETE RESPONSIBILITY FOR PAYING THE APPROPRIATE FEDERAL AND STATE TAXES AS INDEPENDENT CONTRACTORS

ALL AWARDS WILL BE ANNOUNCED AND GIVEN RIGHT BEFORE THE CONCERT STARTS AT THE MAINSTAGE ABOUT 6:15PM.
